The following are clarifications to date based upon questions posed by potential respondents.

1. Can you provide the following information?
  - Seniority list of the current employees for this contract with position, full time or part time status, length of service, and current rate of pay.
  - Current rates/benefits of the current employees with specific information regarding co-pays, dependent coverage and amount of premium paid by employer.
  - **Please refer to Attachment A with the information requested. For premium paid by employer, please refer to Appendix G of the RFP.**
2. Although referenced in addendum 2, can you clarify the exact revenue hours to bid by service?
  - **Please See the Scope of Work provided in RFP (Appendix A) for anticipated service hours.**
3. Although reference in addendum 2, there's no clarity on the vehicle replacement plan. For example, bidders would need to be informed in which years the new vehicles are being placed into service and which vehicles are specifically being replaced? Also, what type of vehicles will they be (make, model, fuel type, seating capacity)?
  - **ICTC intends to work with the operator for the acquisition and implementation of placing new vehicles into service. ICTC currently has 10 new 2023 40 Foot Gilligs (diesel fuel- 40 seating capacity) being placed into service in late FY23-24 or early FY24-25. ICTC also anticipates placing 9 new 2023 Ford E-450 Starcraft cutaways (gas fuel – 20 seating capacity) being placed into service late FY23-24 or early FY24-25. ICTC is also working towards acquiring 9 new Ford E-450 Starcraft cutaways (gas fuel – 16 seating capacity) in FY24-25. The vehicles that would be replaced by the new vehicles is to be determined through**

**discussions with the operator and ICTC.**

4. Although referenced in addendum 2, what is the actual shop equipment available to the selected contract? Please provide a listing of the shop equipment.
  - **Please refer to Attachment B for the list of shop equipment. ICTC will work with the current operator to attempt to acquire the equipment.**
  
5. Can ICTC provide the mile per gallon data, for each of the variant type of vehicles?
  - **The miles per gallon data per variant of vehicles is as follows:**
  - **40 Ft Gillig is 4.6 mpg**
  - **Cutaway is 5.4 mpg**
  - **MV1 is 11.5 mpg**
  - **Vans 11.7 mpg**
  
6. The RFP mentions that the agency will be moving forward with hydrogen in the future.
  - Will ICTC be responsible for providing the hydrogen plant or is this to be provided by the successful bidder?
  - **ICTC will be responsible for providing the hydrogen plant, fuel storage and will work with the vendor to secure hydrogen fuel.**
  - Who will be responsible for the maintenance upkeep and any utilities and fuel chargers regarding the hydrogen plan?
  - **ICTC will work with the current operator to determine the best path forward as it pertains to the implementation of zero emission infrastructure, fuel and vehicles. For the purpose of this RFP, the operator should not consider any pricing for the transition effort at this time.**
  - Will it be the responsibility of ICTC of the successful bidder? Should bidders factor for any of the above items in the next term on their price sheets or is this an item that should not be provided as this will not occur in the next seven years (RFP identified period of performance)?
  - **ICTC will be working diligently to develop the necessary documentation and infrastructure to support the transition to zero emission technology. It is unknown if the transition will take place during the term of this agreement. The vendor should not consider any pricing for the transition effort at this time.**
  
7. Are all MV1's service vehicles? Or can they be used for relief vehicle?
  - **The MV1's are currently being used by road supervisors to supervise service operations on a daily basis and also provide supplementary operating support during special circumstances. The vehicles rarely operate as relief vehicles, but they can. Also, due to lack of available parts for the repairs of MV1's, ICTC is currently exploring acquiring ADA compliant vans as replacement for the MV1's.**
  
8. Would the agency be open for a one-week extension?
  - **ICTC will not give a one-week extension. The proposal due date is April 12, 2024.**
